## **OFFICIAL RULES**

Important: Please read these rules before entering this contest (the "Contest").

By participating in the Contest, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements set forth below.

- HERE PROHIBITED. CONTEST OPEN ONLY TO RESIDENTS OF WASHINGTON STATE WHO RESIDE IN KING, SNOHOMISH OR PIERCE COUNTY AND WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE. IF YOU DO NOT MEET ANY OF THESE REQUIREMENTS, OR ANY OTHER ELIGIBILITY REQUIREMENTS IN THESE OFFICIAL RULES (INCLUDING THE "ADDITIONAL ELIGIBILITY REQUIREMENTS IN SECTION 4), THEN THE SPONSORS (AS DEFINED IN SECTION 14) RESERVE THE RIGHT NOT TO AWARD PRIZES TO YOU. Any web pages, advertisements and promotional materials relating to the Contest are intended for viewing only within the geographic area described above and by eligible participants. You are not authorized to participate in the Contest unless you are located within the geographic area described above and are an eligible participant. To be eligible to win a prize, residents must validly enter the Contest per the terms of Section 6 below. All applicable federal, state and local laws and regulations apply. Limit one (1) prize per household.
- 2. **Disclaimer.** Sponsors and any of their respective parent organizations, subsidiaries, affiliates, directors, officers, professional advisors, employees and agencies (together, the "Released Parties") will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer- or communications-related malfunctions or failures; (c) any Contest disruptions, injuries, losses or damages caused by events beyond the control of Sponsors or by non-authorized human intervention; or (d) any printing or typographical errors in any materials associated with the Contest.
- 3. **Contest Period.** The Contest period ("Contest Period") starts at 12:01 A.M. (all times Pacific Time) on October 1, 2013 and ends at 11:59 P.M. on October 31, 2013 (the "Deadline"). All residents must submit valid entries for the Contest by the Deadline to be eligible to win the prize.
- 4. **Prizes.** Prizes will be awarded as follows: One (1) winner (the "Winner") will receive a home retrofit (the "Retrofit") valued up to \$10,000 by Sound Seismic Earthquake Retrofitting of Seattle, Washington (the "Contractor"). The Retrofit involves reinforcing the connections and framing between the foundation and first floor framing at the perimeter of the basement or crawl space. Prize includes all required building permits and inspections, and structural engineering if needed. Prize will include labor and materials up to \$10,000 but Winner is responsible for any costs, payable to the Contractor, above \$10,000. The total approximate retail value of all prizes and discounts is \$10,000. Retrofit must be completed within one calendar year from date of Winner notification and the Winner is responsible for removing or replacing any finishes that may need to be removed or could be damaged to access the home's structure.

Winner and their home must meet the following eligibility requirements (the "Additional Eligibility Requirements"): (i) the Winner must own a single-family residence (the "Home") in King, Snohomish or Pierce County, within the state of Washington; (ii) the Home must have been built prior to 1980 and have a concrete

foundation (homes with post and pier, slab-on-grade, or cinder block foundation are not eligible); and (iii) the structure elements to be retrofitted on the Home must be accessible to the Contractor.

The Home is subject to on-site inspection by Contractor to verify that it meets the Additional Eligibility Requirements. In the event the chosen Winner is deemed not to have met such Additional Eligibility Requirements, an alternate Winner will be chosen. Contractor will work with the Winner to determine retrofit needs. Sound Seismic, a division of Jackson Remodeling LLC, is a licensed and bonded contractor in the State of Washington (License # JACKSRL016K8).

- 5. Odds. Odds of winning prize depend on the number of eligible participants. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE WINNER. No substitutions or exchanges of any prizes will be permitted. Limit one (1) prize per household.
- 6. **How to Enter.** There are two ways to submit entries for the Contest. First, you may enter by visiting http://shakeout.org/washington/register/ and registering to participate in the 2013 Great Washington ShakeOut (the "Registration Option") during the Contest Period. Second, if you have previously registered to participate in the 2013 Great Washington Shakeout, you may enter by submitting a photo of you (and/or your family) performing an earthquake drill by visiting and uploading such a photo at http://www.shakeout.org/washington/share during the Contest Period (the "Photo Option").

All entries become the sole property of Sponsors. Sponsors will not confirm receipt of entries. A maximum of two entries (one entry under the Registration Option and one entry under the Photo Option) per person or email address (regardless of whether more than one person uses the same e-mail address) per household. Multiple entries, under the Registration Option or the Photo Option, may disqualify you from eligibility to enter the Contest. In the event multiple entries, under the Registration Option or the Photo Option, are received from any person or e-mail address, the first entry processed will be considered the only valid entry received unless Sponsors, in their sole discretion, determine that you are not eligible as a result of your submission of multiple entries under the Registration Option or the Photo Option. In the event of a dispute, online entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry.
